CONTRACT TOPIC:

Authorize the City of Spokane to participate in the Western States Contracting Alliance Master Price Agreement No. AR-1474 with IBM Corporation by signing the Participating Addendum. This makes available to the City favorable pricing discounts for data communications equipment.

CONTRACT BACKGROUND:

The State of Washington is a member of the 15-state Western States Contracting Alliance (WSCA). A recent contract originated by the State of Utah, another WSCA member, was awarded to IBM for the provision of Cisco (among others) data communications equipment at discounts greater than currently available through other contracts. Washington State Department of Information Services (DIS) is working as rapidly as possible to establish the IBM WSCA agreement as a "Statewide Master Contract" and expect to complete it soon. However, in order to complete several urgent projects within the City's MIS department, the City must sign a participating agreement independently of the State DIS so that purchases can be expedited.

Purchases will follow the Spokane Municipal Code for approvals.
